NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

- 1. The name of the Trust is 'JAI MAA EDUCATIONAL AND WELFARE

 2. The Hand off
- The Head office of the trust shall be situated at # 202, Sector 4, Huda, found necessary by the Trustees.
 The area of organization.

The area of operation of the trust shall be the whole of India.

4. THE SOLE AIM AND PURPOSE OF TRUST

The sole aim and purpose of 'JAI MAA EDUCATIONAL AND WELFARE TRUST' is to render educational and welfare activities to the society out of the income earned on the 'Principal Corpus Fund' of the Trust.

In other words the 'Principal Corpus Fund' is to be added, but not to be utilized at any cost, with a view of the longevity of the Trust. The income earned on the 'Principal Corpus Fund' is to be utilized for the activities of the Trust. For undertaking every activity of the Trust, a committee out of the Trustees and volunteers is to be formed. The committee has to work under the chairmanship of the trustee appointed for accomplishing a certain task.

The money collected for that activity and amount sanctioned out of the income of the 'Principal Corpus Fund' is to be utilized. The amount if any saved would be deposited to the 'Principal Corpus Fund' of the Trust.

5. The Objects / Activities of the Trust shall be any or all the following:

- a) To grant scholarships and fellowships, stipends or other periodical monetary help to the deserving students either refundable or otherwise;
- b) To adopt meritorious and needy students from the schools of Naraingarh and around;
- c) To provide computer assistance ANGLE Youth & make them technically sound;
- d) To develop reading habits among youth through a small scale library;
- e) To provide career counseling guidance to the aspirant youth;
- f) To provide medical facilities to the poor in the vicinity through a Dispensary;
- g) To arrange medical checkup camps, blood donation camps through team of specialist doctors from time to time;
- h) To create awareness regarding health & hygiene among the poor.





- To establish, maintain and run or help, by donations, grants or otherwise, in running of schools, vidyapeeths, colleges and study centers and other institutions for imparting education and functional literacy and skills training;

 p) To award prizes, scholarships and fellowships and grants by way of loan and /or otherwise to the deserving students/candidates;





- t) To raise or acquire funds or property from Central Government, State Government, Non-Government agencies, by way of donations or grants or contribution or by taking loan from public and private financial institutions. The funds, properties, assets and all other resources, present and future, of the Trust shall be utilized for any or all the purposes or objects of the Trust as stated above and also for all other similar activities in furtherance of ideals of truth and non-violence;
- u) To achieve the aims and objectives of the Trust as stated above, the Trustees duly authorized through resolution may approach any nationalized bank, private bank, financial institution government sector or private sector to raise loan / credit facilities, to execute all necessary documents as desired by the bank or financial authorities, to mortgage/create charge on the properties/assets of the Trust, to confirm correctness of the balances from time to time:
- v) That the Trust will invest its money and funds according to Section 11(5) of the Income Tax Act, 1961 or according to provision of Income Tax Act applicable at that time.

6. CONDITIONS:

a) That none of the objects of this Trust small at any time involve carrying on of any activity for profits.

b) That the income or the assets of the Trust fund shall not be applied or transferred in whole or in part for any purpose other than charitable and /or educational purpose;

That the income or assets of the Trust shall not be applied or used for the benefit of the authors of the Trust or any person who makes substantial contribution or donations to the trust or any trustee or manager of this Trust.

7. KINDS/TYPES/CATEGORIES OF TRUSTEES

The Trust shall consist of four different categories of members as under:

- Founder Members: A member who has been admitted as a founder contribution to the Corpus of the Trust and has paid the requisite member. The founder members shall also be deemed to have become Life Members of the Trust.
- the prescribed fees as decided by the 3/4 majority of the trustees and such person shall continue to be the trustee of the Trust for his life.
- (iii) Ordinary Member: The Trust shall have ordinary members on the recommendations of trustees who shall continue to enjoy their membership only so long as they are not in arrears of payment of their annual subscription fee. An ordinary member would be admitted as tenure member, say, for a period of two to five years, as the case may be, and he will cease to be a member of the Trust on completion of his/her tenure, unless it is renewed by majority of 3/4 trustees.
- (iv) Honorary Member Individuals of distinguished talent and merit or whose association is deemed to be beneficial to the Trust or who have rendered services of outstanding merit to the society or who is a distinguished citizen of India or any other country may be admitted as Honorary Member of the Trust, after obtaining consent of majority of 2/3 trustees, without payment of any membership or subscription fee. The number of such honorary members shall not exceed 50. The Honorary members shall be entitled to attend the meetings and contribute to the deliberations but shall have no right to vote.

8. MANAGEMENT

The management of the Trust will be governed by the Board of Trustees. The first four founder trustees would form the first Board of Trust. The quorum of the board will be of these four trustees. In case any vacancy occurs due to the death or resignation or any other reason, the same would be filled after the mutual decision of the Board of Trustees in office. The vacancy would be filled from the life, ordinary, Honorary Trustees or of any person outside the Trust if found fit by the majority of the Board of Trustees. The decision of the Board of Trustees in all matters would be final and binding. The permission of the board of Trustees is mandatory to start any activity of the Trust. The board has the power to stop any activity going on if the Board finds it not viable or appropriate without assigning any reason. The management of Trust affairs would be watched in the following ways. The Board of Trust would form a Managing Committee to assist the Board, the following members will be included as the office bearers of Management committee.

The details of the office bearers of first Managing Committee formed to assist the Trust are as follows:

Powers of the Secretary

To maintain accounts of the institution run by the Trust. 2. To prepare Balance Sheet of the Institutions of the Trust annually and put the same before the Trust for approval of every office bearer except Educationist and Staff - representative. 3.

To perform all duties assigned by the President

Powers of the Treasurer

1. To maintain the accounts books and record of the payment and receipts.

The management of the Trust would be observed in view of the following points of the Constitution of the Trust:

- A) The management and control of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase or hold any land and construct any building for the object of the Trust or any fund or any other properties or investment at any time. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and not inconsistent with the provisions of Sections 2(15), 11 to 13 and 80-G of the Income Tax Act, 1961.
- The Trustees shall meet as often as possible but not less than four B) times in a year for efficient management of the Trust and to consider the income and expenditure and or disposing or all such other matters as may arise in such meetings.
- At least two Trustees or one third of the total number of Trustees for C) the time being (fraction being omitted) whichever be greater present within half an hour of the time fixed for the meeting shall form quorum; if no quorum be present even after expiry of the half an hour, the meeting shall stand adjourned to such date, hour and place as may With Seems Ram

be fixed. When the meeting has been adjourned for want of quorum, not withstanding anything stated above, the Trustees present at the adjourned meeting shall constitute quorum for the next meeting.

- D) The meetings of the Trustees shall be convened at such place in India and at such hour and on such date as may be agreed upon by the Trustees, .
- E) All the meetings of Trustees, and all decisions of the Trustees shall be by majority vote.
- F) All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.
- G) A trustee who fail to attend three consecutive meetings without prior intimation or information shall cease to be a trustee, unless otherwise majority of other Trustees accord him exception on genuine and valid grounds.
- In case of difference of opinion arising among the Trustees and in all H) matters wherein the Trustees have discretionary power, the votes of the majority of the Trustees for the time being shall prevail and be binding on the minority as well as on those Trustees who may not have remained present or voted. In case the Trustees are equally divided in opinion, the matter shall be decided according to the casting vote of the Chairman selected by the founder trustees.
- It shall be lawful of Trustees to pass resolutions, postal or other I) communications and such resolutions, shall be called "circular resolution".
- If any of the Trustees either founder or appointed later under the J) presents in pursuance of the provision hereinbefore containing that for or be desirous of being relieved or refuse to act or become until or incapable to act in the duties and powers reposed in him or be declared insolvent or convicted of a criminal offence involving moral surface he or she shall cease to be a Trustees, and thereupon a vacangy deemed to have arisen among the Trustees, and then and so often as the same shall happen, it shall be competent for the continuing or surviving Trustees or Trustees in his or her place, it shall be also competent for the Trustees for the time being of these presents from time to time to appoint new exceeding and the provisions made hereinabove are observed. - A) To manage Trust funds and collect and recover the interest, income and profits thereof and to pay there out the expenses of collection and
- B) The Trustees shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such powers are not specifically
- C) The Trustees shall be entitled from time to time to open, maintain and operate a Bank account or accounts in the name of the Trust or in the Institutions of Trust at such Bank or Banks as they from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund or the income thereof to the credit of any such account or accounts either by way of Fixed or Current Account or any other account. Any such account shall be operated by any two of the trustees appointed by resolution made by the 2/3 majority of the trustees.
- The Trustees shall have powers to maintain and defend all suits D) and take such other steps as may be reasonable and requisite for the preservation of the Trust Property and the protection of the title thereof. At the discretion of the Trustees, authorized persons shall represent them in all such proceedings.
- E) The Trustees are bound by all the liabilities cast upon them under the Indian Trusts Act, 1882 except to the extent of the powers specifically conferred under these presents.
- The Trustees may at any time receive voluntary contributions from any F) person or persons by donation, legacy, gift, annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- Proper accounts showing all the receipts and disbursements made on G) account of the Trust hereby constituted shall be kept by the Trustees who shall prepare Receipts and Payment Account, Income and Villy Seema Rank

Expenditure Account and Balance Sheet as on March 31st every year and shall be duly audited by a qualified Chartered Accountant.

H) The Trustees may appoint regular, permanent, part time or honorary staff if necessary according to the requirement for the managing or working of the Trust and use the Trust Funds for payment of their salaries, compensation or expenses, etc.

Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem expedient either on the mortgage of the whole or any part of the property of the Trust, or by bonds, debentures, deposit receipts, promissory notes, with or without security or insuch other manner as they may consider proper.

All the funds of the Trust shall be dealt with under section 13 of the Income Tax Act of 1961.

K) The Trustees may reimburse themselves and pay and discharge out of the Trust funds all expenses incurred by them in or about the execution of the Trust or in exercise of powers conferred under these presents.

L) It will be lawful for the Trustees to delegate any of their powers for limited purposes of management to any one or more of the trustees jointly and /or severally, and if necessary to cancel or modify the same.

M) The Trustees shall be entitled to authorize by a resolution any one or more of the Trustees to receive money payable to the Trust and to pass receipts for the same, and such receipts shall discharge the person persons making the payments without they being bound to see to the application thereof and without they being liable or answerable for this or misapplication thereof.

N) The Trustees shall also be entitled to take over the management of any other Trust or Institutions as well as carry out the trust under any deed or Trusts for religious and or charitable purposes set out hereinabove on such terms and conditions as may be thought fit by them in their absolute discretion provided that they are not inconsistent with the terms hereof or the objects of the Trust set out in this Trust Deed.

O) The trustees shall have powers to amalgamate with and /or take over other Trust or Trusts having wholly public charitable objects.

The Trustees will manage the subject-matter of the Trust and take decisions regarding the matter of polices concerning the fulfillment of its objects as the majority of Trustees may decide.

The Trustees shall, out of the income of the Trust in the first instance, pay all management charges incidental to the management and the administration of the Trust, its properties and assets, and shall utilize the net income for the charitable objects aforesaid in the best possible manner in accordance with the objects of the Trust.


Any Trust property held in the name of outgoing or dead Trustee shall automatically stand transferred with all convenient dispatch from his name to the surviving trustees. Upon every appointment of new Trustee or Trustees as laid down below, the trust property and other funds shall, if and so far as the nature of the property and other circumstances shall require or admit or, Trustees for the time being, and every Trustees so appointed as aforesaid may, before as well as after, such transfer of the property, act and assist in the execution of the Trust and exercise of powers under these presents as fully and effectually as if he had been appointed under these presents.

The Trustees shall be respectively answerable only for such monies or securities or other property as they shall respectively actually receive notwithstanding their signing any receipt for the sake of conformity or advance receipt and shall respectively be so answerable and accountable only for their own respective acts, receipts, omissions, neglects and defaults and nor for these of each other or for any banker, broker, auctioneer or other persons with whom or into whose hands any Trust money, funds or securities may be deposited by have some or for any insufficiency in title or deficiency in value of any investments, nor for any other loss unless the same shall happen through their own respective willful default or dishonesty.

The Trustees shall have power to keep invested the Trust Funds in suitable avenues, keeping in view the safety of the investment, including movable and immovable properties, shares, deposits in banks, debentures, government securities and loans, stocks, deposits with post office and other government institutions in conformity with the provisions of the Income Tax Act and other laws: provided always that the Trustees shall have power to sell, convert or vary the said investments into investments of the same or other kind or nature authorized by these presents or resell, convert or realize the said

- (i) The Trust may resolve to dissolve itself in accordance with the provisions contained in the Act and the rules there under in case it becomes difficult to carry on with the operations of the Trust, or it becomes insolvent or for any other pressing and unavoidable reasons.
- (ii) In the event of dissolution of the Trust, no assets of the Trust shall devolve on or distributed amongst the trustees of the Trust.
